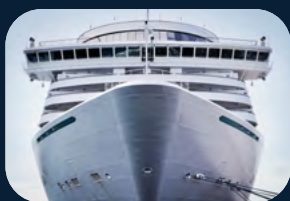

3 STOP THREE Cedar Creek Saloon

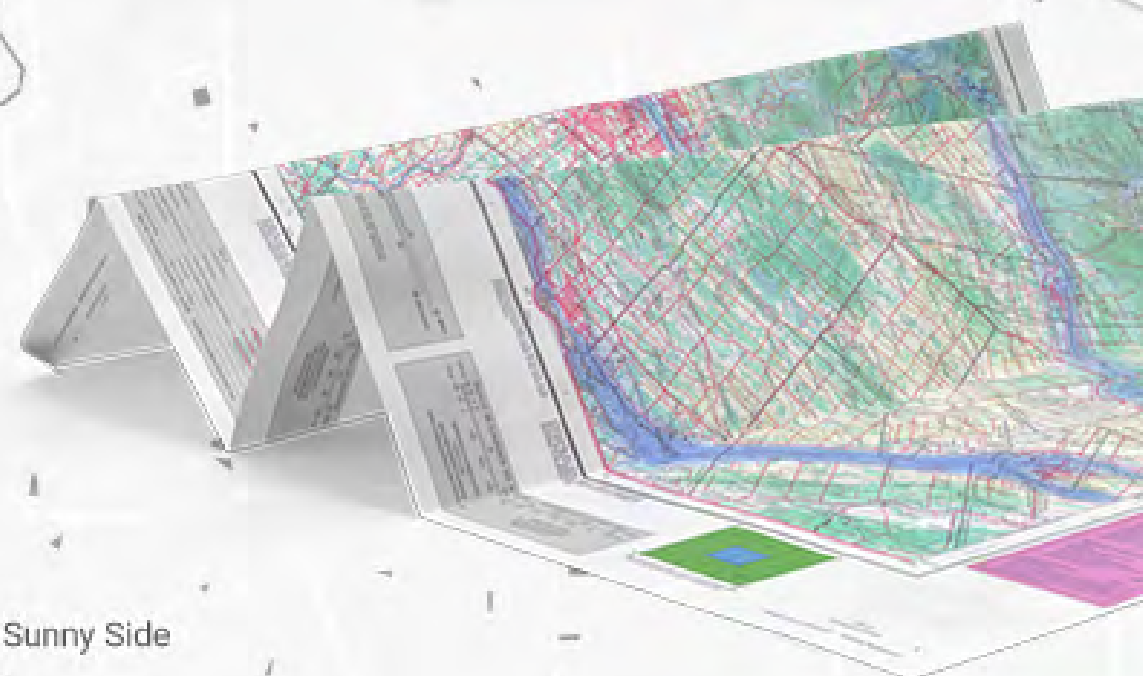
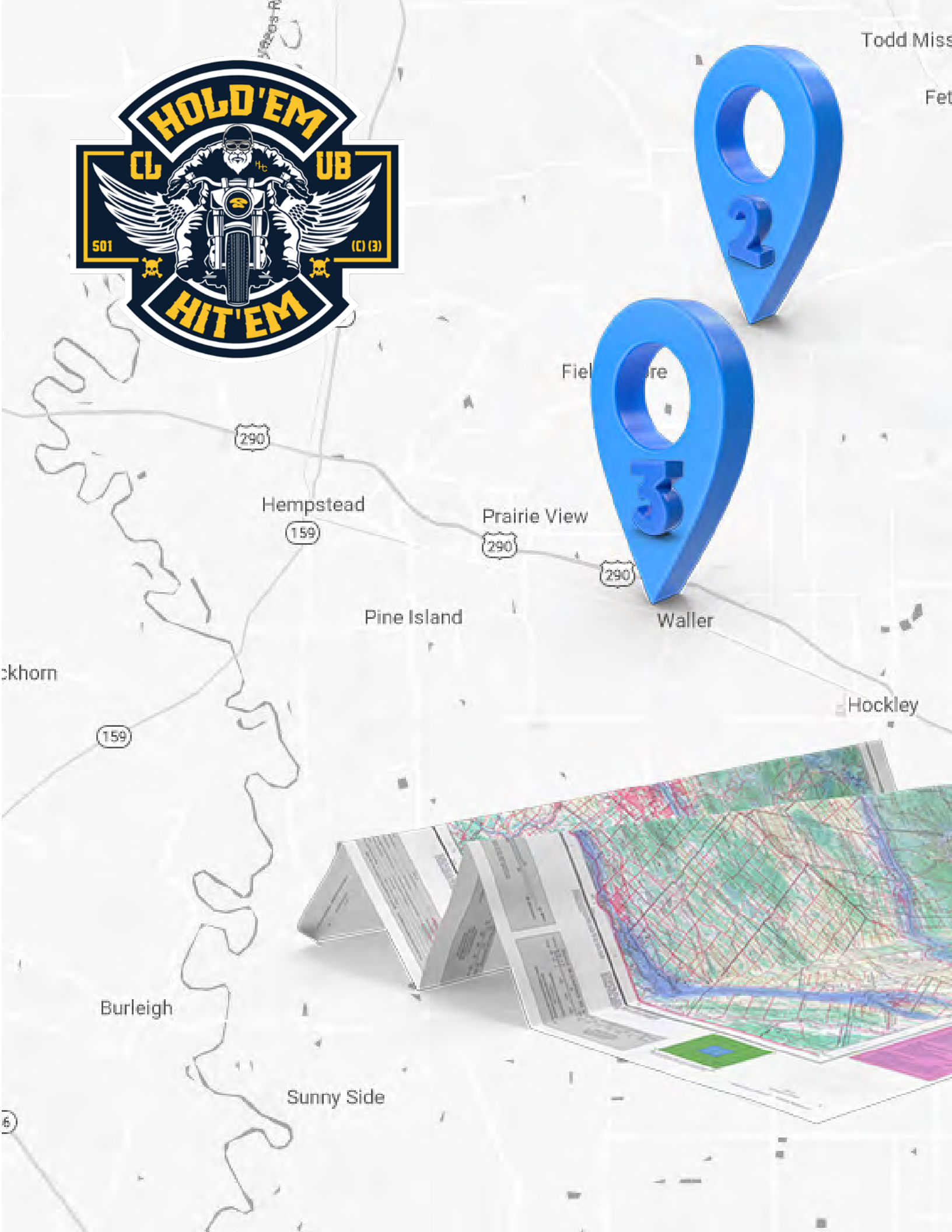
Where the road goes on forever and the party never ends! Located on the corner of Hwy 290 and FM 362 (right next to Waller County Line BBQ).

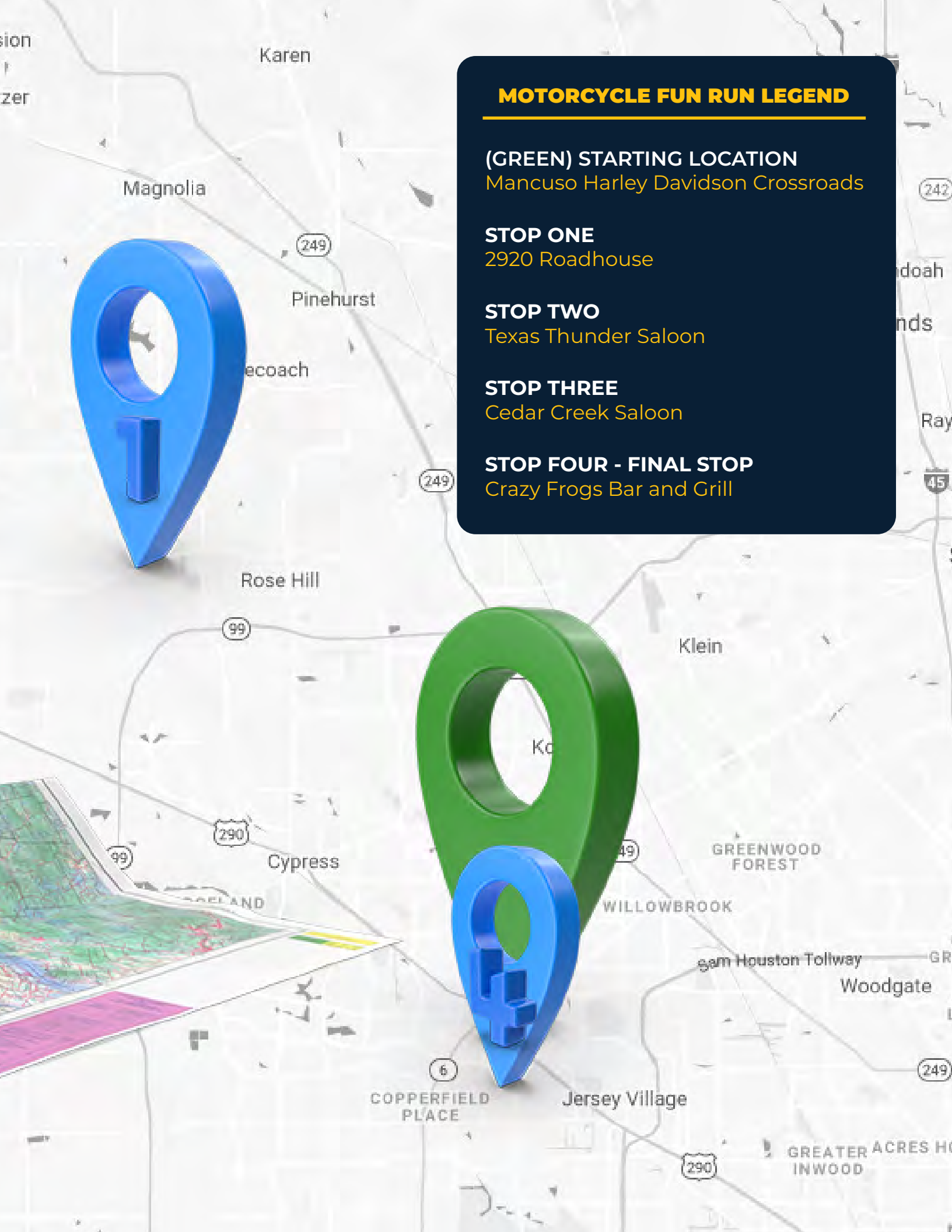
